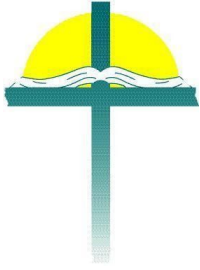

PROPERTY TAX DECLARATION Support Yellowknife Catholic Schools

If you are a property owner in the City of Yellowknife, you will soon receive your Notice of Assessment. All ratepayers in the City of Yellowknife have the option of allocating where their school property taxes are going. Check the school declaration portion of your Notice of Assessment to see where your taxes are going. You have three options – 100% Yellowknife Catholic Schools or YK1, split by enrolment or a custom declaration. If a ratepayer does not declare a specific school tax support then taxes are allocated by enrolment to each school board. If you wish to change your support, the property owner must complete and submit a **School Support Declaration Form**.

Anyone wishing to change their school support declaration must complete the [School Support Declaration](#) form and file it with the Secretary of the Board of Revision by February 19, 2021. Forms can be:

If you wish to make a school declaration, the deadline is February 19, 2021.
